Unaudited Operating Figures for the Fourth Quarter and Year ended 31 March 2017

The board of directors (the “**Board**”) of China South City Holdings Limited (the “**Company**”) announces that the Company and its subsidiaries (the “**Group**”) recorded contracted sales of approximately HK\$8,636 million for the year of FY2016/17 ended 31 March 2017, with gross floor area of approximately 1,083,000 sq. m. at an average selling price of approximately HK\$8,000/sq. m.. As compared to the contracted sales of last year, it represents a year-on-year increase of 30.3% (FY2015/16 full year: HK\$6,628 million). The contracted sales of the fourth quarter of FY2016/17 (from 1 January to 31 March 2017) was HK\$1,897 million. As compared to the contracted sales of the fourth quarter of last fiscal year, it represents an increase of 25.5% (FY2015/16 fourth quarter: HK\$1,511 million).

The above-mentioned sales data is unaudited and is based on preliminary internal information of the Group, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or half-yearly basis due to various uncertainties during the process of collating such sales information. They shall not be taken as a measure or indication of the Group’s current or future operating or financial performance. As such, the above data is provided for investors’ reference only.
